REGULATIONS:

REGISTRATION DEADLINE: Candidates must complete the registration form and return it to the registrar at the above address by the registration deadline at the top of this page. Registrations received after the deadline may be disqualified, or if accepted, will be subject to a \$100.00 late penalty fee, without exception.

REFUND POLICY:

Full refund The Canadian Gemmological Association shall refund all the fees paid by the candidate under a contract in the following circumstances:

1. The contract is rescinded by the candidate within two days of submitting payment to the CGA.
2. The CGA cancels the applicable session of examinations.

Partial refund If a candidate registers and pays fees for exams but does not write the exam(s), the CGA shall refund part of the fees under the following circumstances:

1. The candidate gives the CGA notice of withdrawal at least 21 days before the exam is scheduled.
2. The amount of the refund shall be an amount equal to the full exam fee paid, less an amount equal to the lesser of 20 percent and \$250.

DEFERRALS: Candidates who have registered to write the exam(s) in any given exam session may request a ONE-TIME-ONLY deferral of their exams to the next exam session. **For example, if scheduled to write in January, they may defer to June of that year. After that, full exam fees will apply.** Deferrals are subject to CGA approval and require completion of a formal deferral request, and an accompanying non-refundable payment of \$100 per day of exams deferred.

MARKING: The morning and afternoon sessions of each theory exam are considered together for a single grade. Theory exams are written on the same day everywhere. The practical portion of the professional-level exam is marked separately. **A minimum passing grade is B (67%).** The practical and theory portions of the professional-level exams must be passed within one year of each other. **When all exams are written in the same exam session, the professional-level exams will be deemed to be “failed unmarked” if the preliminary exam is failed.** All submitted scripts become the property of the CGA, and apart from notifying candidates of the grade achieved, the CGA is unable to enter into correspondence about examination results.

DESIGNATION:

You are only entitled to use your FCGmA Designation if you are a current paid Fellow of the CGA. Memberships run yearly from January 1 to December 31.
